## CORROSION & SALT FOG TESTING

Industrial Rivet maintains multiple 22 cubic foot cabinets conforming to ASTM B117 continuously. Parts of various sizes can be accommodated in the chamber. Parts often go into the cabinet the same day received. Upon test completion, parts are evaluated and test reports generated quickly.
